

Terms and Conditions Home Renewal & Protection Bundle Promotion 1 October 2023 – 31 March 2024

- This Home Renewal & Protection Bundle ("Promotion"), organised by Tiq by Etiqa Insurance Pte. Ltd. ("Etiqa"), is valid from 1 October 2023 to 31 March 2024, both dates inclusive ("Promotion Period").
- 2. This Promotion is open to all Singapore citizen(s), Singapore Permanent Resident(s) and Foreigner(s) with valid Work Pass, Student Pass, Dependant's Pass or Long-Term Visit Pass.
- 3. This Promotion is only applicable for the online application or purchase of the eligible products set out in the table below ("Eligible Products") via <u>www.tiq.com.sg</u> or via the **Tiq by Etiqa mobile app** during the Promotion Period.

4. Sign-Up Gift

Customers will be entitled to a Sterra Moon[™] True HEPA-13 Air Purifier (worth S\$229) ("Sign-Up Gift") when the following are complied with during the Promotion Period:

- a) Existing customer successfully paid for the renewal of their Tiq Home Insurance; and
- b) The customer purchases of 1 or more eligible life protection product(s) (3 Plus Critical Illness, Cancer Insurance, ePROTECT term life or DIRECT – Etiqa term life) ("Eligible Life Protection Products") within the same calendar month; and
- c) The total combined initial premium (first premium paid) of the Eligible Product(s) renewed and purchased meet the minimum spend of S\$1,000 ("Minimum Spend").
- 5. Please refer to the following Qualifying Criteria for further details:

Please refer to the Cancellation and Refund clause in the full policy wording <u>here.</u> Other terms and conditions for Tiq Home Insurance still applies. (iii) If the customer needs to cancel the renewed policy due to
	a change in home address or passing of the main policy holder, proof of change in home address or death must be



	provided for the additional cancellation charge of S\$229 to be waived.
b) 3 Plus Critical Illnessc) Cancer Insuranced) ePROTECT <i>term life</i>	(i) Purchase one or more of the Eligible Life Protection policies
e) DIRECT – Etiqa <i>term life</i>	 (ii) Individual policy holders who are from the same household, and share the same registered home address may combine their policy premiums to meet the Minimum Spend

For example:

- i) Customer paid premium for the renewal of Tiq Home Insurance on 1 November 2023 via the Tiq website, while selecting the policy start date as 1 December 2023.
- ii) The same Customer or a member of the same household then purchased a 3 Plus Critical Illness plan on 15 November 2023 via the Tiq by Etiqa mobile app.
- iii) The Customer is eligible to receive the Sign-Up Gift as long as the minimum premium paid for both policies meet the Minimum Spend and both policies passes the 14 days Free-Look Period without cancellation.

- 9. A redemption email for the Sign-Up Gift will be sent to the eligible customers' email address within **60 days** after the Free Look period from the last policy purchased. The details in the redemption email shall form part of these terms and conditions. Any Sign-Up Gift which remained unclaimed after **30 days** of notification shall be forfeited.
- 10. This Promotion is not valid for customers who have cancelled or free-look existing policy / policies with Etiqa within the last 14 days.
- 11. This Promotion is not valid in conjunction with any on-going existing insurance promotions, coupons, staff discounts and privileges, unless otherwise stated.
- 12. Existing terms and conditions for the Eligible Products apply.
- 13. In the event of any inconsistency between these terms and conditions and any advertising, publicity, brochure, marketing or other materials relating to or in connection with the Promotion, these terms and conditions shall prevail.

Any such dispute relating to the Sign-Up Gift should be resolved directly with the merchant/retailer and Etiqa shall have no liability with regard to such dispute.

- 18. If Etiqa subsequently determines that a person is in fact not eligible to participate in this Promotion, for any reason whatsoever, Etiqa may at its discretion, disqualify that person and claw back/cancel the Sign-Up Gift without prior notice.
