

Terms and Conditions

Summer Petmania 2024 x Tiq by Etiqa Pet Insurance Spin & Win Lucky Draw

- 2. This Promotion and Lucky Draw is open to all Singapore citizen(s), Singapore Permanent Resident(s) and Foreigner(s) with valid Work Pass, Student Pass, Dependent's Pass or Long-Term Visit Pass.
